There are three (3) cards you should have if you are eligible: the BCBS Card, an Express Script Card, and a *RED BENNY CARD*. The Benny card looks like a credit card. It is red with a VISA logo in the bottom corner and has Benny Card written on it. It can be used for any medical cost, prescription, vision, dental, copays, and self pays. The money that is put on per the contract is .67 cents per hour. That is your money to use for medical expenses with no expiration. There is **NO** Dental Card because that is handled by Tri-State directly.
