To all contractors who employ Ironworkers in the jurisdiction of **Ironworkers Local Union #498**:
Please be advised that effective **June 1, 2023 through May 31, 2024**, wage rates will be as follows:

Hourly wage for:	Regular	Time and a half	Double Time
Journeyman	\$45.18	\$67.77	\$90.36
Foreman with 2 men or less	\$48.34	\$72.51	\$96.68
Foreman with 3 men or more	\$50.60	\$75.90	\$101.20
General Foreman	\$52.86	\$79.29	\$105.72

The guidelines for overtime pay are:

If you are working a National Maintenance Agreement, metal building construction or some Project Labor Agreements you are to pay time and a half for overtime. If it is new construction overtime is double time.

Apprentice Rates are as follows:


